

# Latrobe City Council Submission to:

Infrastructure Victoria 30 - Year Strategy May 2025



#### Introduction

Latrobe City Council welcomes the opportunity to contribute to Infrastructure Victoria's 30-Year Strategy and appreciates the consultative approach to inform the state's long-term infrastructure planning.

Located 135 kilometres east of Melbourne, Latrobe City is home to **77,606** residents and plays a pivotal role in the Gippsland region's economy. With an annual economic output of **\$13.7 billion** and more than **35,000 jobs**, almost **30 per cent** of all regional employment, Latrobe City is a major economic and employment hub for Gippsland and the Victorian economy more broadly.<sup>1</sup>

The city boasts access to high-quality education providers, including TAFE Gippsland and Federation University, a strong health precinct, and a range of recreational, retail, and cultural amenities, enhancing its reputation as one of Victoria's four key regional cities.

Latrobe City is serviced by the Gippsland rail line, offering established but limited public transport connectivity. Housing affordability is also a notable strength, with median house prices ranging from **\$330K to \$480K**, significantly more affordable than neighbouring municipalities, where median prices reach **\$665K**. This affordability presents a major opportunity for population attraction and economic transformation. <sup>2</sup>

For over 100 years, Latrobe City has underpinned Victoria's electricity generation, but the impending closure of Yallourn Power Station (2028) and Loy Yang A (2035) represents one of the most significant economic and land use transitions in Victoria's history. These closures will have farreaching social, economic, and environmental impacts on the community and require strategic infrastructure investment and strong intergovernmental coordination and support to ensure the Latrobe City economy continues to thrive.

Given the scale and impact of the region's energy transition, it is essential that the Strategy explicitly acknowledges the closure of Latrobe City's coal mines and power stations. These changes will profoundly shape the region's future, and Infrastructure Victoria has a critical role to play in ensuring this economic transformation supports a prosperous, resilient, and equitable future for the Latrobe City community.

#### Submission

Council supports in full or in part several recommendations of the draft that are aimed at improving access to housing, jobs, services, and educational opportunities. These include expanding social housing supply, facilitating kindergarten infrastructure investment, improving school planning and delivery, expanding TAFE and skills training, enhancing regional public transport, and rezoning land to unlock housing and employment potential. Notably, we propose the incorporation of **inclusionary zoning** and removal of **redundant coal overlays** to support development in areas such as Area H. These changes will significantly assist in Latrobe's growth and economic diversification, ensuring future prosperity.

Council also highlights the need for safer local streets for children and calls for planning that includes adequate school drop-off zones and buffers for childcare centres. Additionally, Council fully supports updated flood mapping and recommend the **Traralgon Bypass and retarding basin** be identified as critical infrastructure for climate resilience.

In support of Council's detailed feedback (attached), Council puts forward two additional key recommendations to strengthen Infrastructure Victoria's 30-Year Strategy and ensure it adequately responds to the unique challenges and opportunities facing Latrobe City.

#### **Council Recommendations**

# Recommendation 1: Recognise the requirement for mine rehabilitation as part of the strategy.

Council strongly advocates for Infrastructure Victoria to formally recognise the rehabilitation of declared mine land in Latrobe City as a priority within the 30-Year Infrastructure Strategy. The scale and complexity of mine rehabilitation demands long-term planning, clear governance, and dedicated investment well beyond short-term remediation measures.

The ongoing uncertainty around post-closure land uses and the extended rehabilitation timelines continue to raise concern within the Latrobe City community. Given the significant and lasting implications for Gippsland's economy, environment, and community wellbeing, mine rehabilitation must be treated as a critical part of future infrastructure development and all visionary planning.

Council recommends that Infrastructure Victoria:

- a. Formally recognise mine rehabilitation in Latrobe City as part of the 30-year strategy.
- b. Provide ongoing support for Mine Land Rehabilitation Authority to ensure strong regulatory oversight and continuity.
- c. Mandate progressive rehabilitation practices to enable timely, staged outcomes that support environmental sustainability and future land use.
- d. Preserve opportunities for appropriate, future economic use of remaining brown coal resources when aligned with the public interest.
- e. Address land tenure challenges by exploring options such as government ownership or consolidated land titles to support long-term landform stability and public benefit.

This recommendation is essential to ensure that Gippsland's post-mining transition is supported by robust infrastructure planning, delivering sustainable outcomes for generations to come.

# Recommendation 2: Shift from a city-centric approach to a balanced strategy with adequate investment for Regional Victoria, including Gippsland.

Council strongly advocates for a shift from the current city-centric focus of the 30-Year Strategy to a more balanced approach that ensures Regional Victoria, particularly Gippsland, receives adequate infrastructure investment. This should include prioritising key road, rail and water projects that enhance connectivity, support economic development, facilitate land activation, and foster population retention in the region.

Council recommends that Infrastructure Victoria:

- a. Increase investment in regional transport infrastructure, including upgrades to the Gippsland rail line for both freight and passenger services and road networks including the Traralgon Bypass, to support economic diversification and improve accessibility to regional centres.
- b. Ensure that Regional Victoria, including Latrobe City, is adequately considered in infrastructure planning, with specific projects designed to address the economic and social challenges presented by the energy transition.
- c. Align investment in regional infrastructure with long-term plans to create sustainable, thriving communities across Regional Victoria, not just in metropolitan areas.
- d. Expand on the current circular economy pillar to incorporate regional opportunities including the proposed waste to energy station at Opal. This recommendation is crucial to ensure that regional communities like Latrobe City are not left behind as the state moves forward with its long-term infrastructure planning.

#### Conclusion

Council acknowledges the importance of Infrastructure Victoria's 30-Year Strategy in shaping longterm infrastructure decisions across the state. However, we are concerned that the current draft does not adequately address the transformational economic and land use impacts resulting from the imminent closures of the Yallourn and Loy Yang A power stations and associated mines, arguably one of the most significant transitions in Victoria's history. These events present both major risks and critical opportunities.

Council urges Infrastructure Victoria to play a leadership role by explicitly recognising mine rehabilitation as part of the Strategy. This includes supporting a coordinated and well governed approach that ensures appropriate long-term planning, regulation oversight and sustained investment in mine rehabilitation to secure environmental stability and enable future land use outcomes.

In addition, Council also calls for a shift away from a city-centric focus toward a balanced approach that delivers meaningful infrastructure investment across all Regional Victoria, particularly in Gippsland, where this investment is essential to enabling economic diversification and long-term resilience.

Council's recommendations aim to strengthen the Strategy by ensuring it more effectively responds to the unique challenges facing Latrobe City and capitalises on the region's significant potential for Strategy.

2. Tell us why	The Latrobe City area has 2152 social and affordable dwellings.  In 2024, Council undertook Planning Scheme Amendment C136 which highlighted a need of over 3,000 new social and affordable dwellings to meet current demand. This figure represents 75% of the Council's projected future dwelling stock.  Fulfilling the shortfall in social and affordable dwellings realistically poses challenges due to criteria related to proximity to amenities such as public transport and retail services.

Include proposed changes and improvements	Officers would like to see inclusionary zoning incorporated into the Planning Scheme that would establish triggers enabling developers to deliver social housing.  For example, the Baldwin Road development in Traralgon North was rezoned in 2023 for residential housing and is in close proximity to services and amenities so would be well placed to benefit from the inclusionary zoning.

Share any supporting A desktop analysis conducted in October of 2024 by Council Officers evidence or examples indicated that at least twenty new kindergarten rooms would be needed to meet the Victorian State Governments reform requirements. Of these twenty rooms/facilities, five had already been developed or were under construction at the time the analysis was While the Victorian State Government have previously covered the construction costs, expenses related to furnishing, fit-outs, annual maintenance, and utilities have not been factored in. At time of running the report Council was projected to incur the following costs: Furnishing and fit outs: \$1.8 million (with \$600K already funded) Annual maintenance for additional facilities \$150k annually Increased utility costs \$60K annually. It is understood that the Victorian State Government has contributed approximately \$9.5 million to date, with an additional \$22.5 million

10. Tell us why	Latrobe City's land is heavily restricted from a planning perspective with flood overlays, industrial zoned land, pipeline easements, regional outfalls, separation distances guidelines, SRO and ESO1 making it challenging to find suitable pockets of land for schools.
11. Share any supporting evidence or examples	Traralgon East being a prime example of these difficulties.
12. Include proposed changes and improvements	The system for selecting land for future school use is inefficient and individual developers are responsible for identifying school sites. Part of the solution being recommended by Council Officers is that the Victorian State Government should acquire land earlier in the process and pay market value to the landowners. Regional Plans should also be developed, and acquisition overlays implemented that are consistent with the Victorian Government's school site selection criteria.  Suitable school sites should also include allowances for school pick-up and drop-off areas within the school grounds. Relying on side streets is unacceptable and often unsafe with surrounding streets often becoming double-parked.
	Additionally, when school sites are selected, plans should be established for active transport so that children can walk or ride bikes to school safely.

Additionally, expanded educational opportunities can help significantly improve employment outcomes.  Currently the unemployment rate in Latrobe City sits at 5.3% with

This approach would encourage them to study, work, and ultimately build their careers in the region.

3. Share any supporting evidence or examples	The Latrobe City area currently has 43,000 hectares of land currently constrained by ESO1, SRO, and SUZ1 zones that prohibit development. (Map attached)
	Area H is a large portion of that constrained land and connects Morwell to Traralgon south of the Highway it is unique as unlike a large part of the land in the Latrobe City area it is not subject to flooding or bushfires making it a prime location for future development.
	Additionally, its proximity to residential areas and Latrobe Regional Hospital makes it unsuitable for mining. Therefore, removing the coal overlay is the sensible thing to do.
	As mentioned throughout this submission population attraction and retention is a top priority for Council as evidence suggests it will support the economic diversification of the economy, something that critically needed with the closure of Yallourn and Loy Yang A mine and power station fast approaching.

	A standard train trip from Traralgon to Flinders Street station in Melbourne is approximately 2 hours and 15 minutes double the commute time of other regional cities.

Do you support this topic or recommendation?	Yes
2. Tell us why	Bus services do not keep pace with growth and lag behind infrastructure development, causing issues with traffic congestion in and around growing communities, including growing areas in Regional Victoria. When development occurs there is no clear timeline for when new bus services will be delivered, often resulting in bus stops being built that are out of service for many years.  Additionally, some smaller regional townships are not serviced by buses at all. Running more bus services will improve connectivity and access for the community.
3. Share any supporting evidence or examples	For example, Tyres, Glengarry, and Toongabbie all growing small towns in Latrobe, are not currently serviced by local buses.  Additionally, local services to key infrastructure such as Latrobe Regional Health and retail trade presidents are not always direct or efficient.
Include proposed changes and improvements	Council is supportive of IV recommendation to run more bus services in Regional Victoria and encourage them to expand the scope of the recommendation requesting the Victorian State Government establish individual bus plans of all regional communities.

6. Tell us why	Making local streets safer for children and communities is an objective Council supports. While Council understand IV desire to reduce speed limit to 30km on local streets, starting in places that children often visit including around schools, playgrounds, childcare centers and kindergartens, Council emphasis that this is not a strategy that should be implemented in isolation or in lue of other road safety approaches.
7. Share any supporting evidence or examples	
8. Include proposed changes and improvements	Council encourages IV to recommend that the Victorian State Government include suitable school drop off zones and car parking sites inside of School property to improve safety.
	Council also encourages further consideration of planning regulations regarding the placement of childcare centers to ensure they are situated in areas that have adequate industrial buffers to avoid conflicts with freight requirements. For example, childcare centers should not be located next to heavy mechanics, which typically have high traffic.

2. Tell us why	Council Officers advise that they are up to date with current flood mapping.

Share any supporting evidence or examples	Current emergency management systems that support the flooding events of Traralgon Creek are insufficient. On average the town suffers from a significant flooding event every 7 years.  Building the Traralgon Bypass and incorporating a retarding basin, will help future-proof the township from future flood events.  The Traralgon Bypass has been formally included in the Latrobe Planning Scheme with Regional Roads Victoria completed preliminary works on the economic, environmental, social and traffic impacts of delivery.  Progress on the project was hindered due to the proximity to Loy Yang mine, however with the closure scheduled for 2035 Council encourages progress to be made to support the delivery of this project.
Include proposed changes and improvements	Council recommends that IV expand on this current recommendation and include a list of Infrastructure projects that will enable climate resilience including the Traralgon Bypass and the proposed retarding basin.
	Additionally, Council recommends that a funding stream be made available to support the re-build of Infrastructure projects following natural disasters which would support projects such as Councils Flood Recovery Project to be delivered sooner.

This area would benefit significantly from smart traffic technology the adapts in real-time to actual traffic conditions, helping to clear congestion more effectively rather than relying on static speed reductions like the 30km/h limit. Modern smart traffic lights offer a proactive solution to keep Traralgon moving while we wait for a proper bypass.

Developing and publishing a 30-year integrated rail freight network plan, alongside a funded 10-year rail freight maintenance program, will stimulate growth in sectors such as manufacturing, agriculture, and retail by improving access to markets.
Council recommends that IV expand this recommendation to consider freight services that can support faster and more efficient passenger operations on the Gippsland train line.  In addition, Council requests that any required maintenance or upgrades to the Gippsland train line be prioritized to support the region's economic diversification.
